



Terms of usage for tee time reservation system – Caesarea Golf Club (the "Club")

1. The tee time reservation system (the "system") is a system that operates over the internet and requires internet access.
2. The system is managed by the Club ("System Manager").
3. The system is intended for the use of Club members only, who are registered with the system and who have agreed to and signed these terms of usage. It should be noted that any tee time reservation by non-members must be made through the Golf Shop.
4. The system is in Hebrew only.
5. The system is a reservation system for the Pete Dye Championship Course at the Caesarea Golf Club.
6. All entries into the system will be under a user name and password. The user name and password are personal and will only be issued to Club members through an automatic email once the system opens or personally, to the member by a Club representative.
7. Following a tee time reservation via the system, the relevant details will be displayed by the system: the name of the member, the tee time and names of additional players. These details will be displayed by the system and visible to all Club members using the system. Upon logging into the system all club members can view the time slot reservations list including names of all players who have registered for all time slots until that time.
8. A club member who does not wish to have his name displayed in the manner described above will be unable to reserve tee time through the system and will need to reserve tee time through the Golf Shop. In such an event, instead of the player's name, his subscription number or other code name will be displayed, as decided by the system manager.
9. The system can differentiate between different types of memberships. An attempt to reserve a tee time that is not in accordance with the membership terms, will result in the payment of a game fee in accordance with the Club price list for that day.
10. Access to the system will be for the duration of the membership and will be automatically shut off when the membership ends (unless the subscription is renewed).
11. The system allows the reservation of tee time per member per day (Reservation for more than one tee time under the same member name for the same day is not possible).
12. All tee time reservations will be automatically confirmed with an email to the Club member making the reservation. Email confirmation will also be sent if the game time slot was reserved through the Golf Shop. In the event that no email address was provided for the club member, no confirmation will be sent.
13. A member may reserve tee time for himself and other members, providing he has their agreement in advance and on condition that he enters the user names and passwords of those members playing with him. Revealing user name and password to another member will be at the sole discretion of the information giver and on his sole responsibility.
14. It is the responsibility of the Club member who reserves a tee time for other members, to inform them the reservation has been made by him.
15. Cancellation of a tee time reservation – members are responsible for cancelling tee time reservations either via the system or by informing the Golf Shop in advance that the tee time reserved for him is no longer needed. This applies if the tee time has been made by him or by another member.
16. Only groups of three or four players may start to play. Couples or individuals may not tee off. Couples or individuals wishing to reserve a tee time are required to join an existing group (couple or individual) or to register for a new tee time on the understanding that if the minimum number of players is not met, they will have to wait until additional players join the group.
17. The system manager is authorized to make changes to reservations made by Club members with the system, providing he informs the members in advance.
18. Club management reserves the right to alter, from time to time, registration times and terms and to make changes to the system and its terms of usage.
19. These terms do not negate the terms of usage displayed and detailed on the Caesarea Development Corporation internet site governing the usage of that site or the rules and regulations governing the Caesarea Golf club but are in addition to them.

I agree to the terms detailed in this document and confirm that I am aware that, so long as I use the system, my full name, tee times I have reserved and group members playing with me will be displayed by the system which works over the internet. I confirm that I will have no claim and/or case and/or demands regarding the usage of the system or anything resulting from it including the aforementioned details, either against the club and/or the Caesarea Development Corporation and/or its employees and/or anyone acting on their behalf.
